Dr. Miller has early onset Alzheimer's and there was fear if this recognition was postponed by a year, he may not understand the honor and recognition he is being awarded. Dr. Marotta feels strongly Dr. Miller is deserving of faculty emeritus status and is looking for support from the committee in bringing a motion forward to the full board requesting such approval with the caveat that the Faculty Emeritus Committee approves Dr. Miller's nomination prior to the full board meeting. Committee members unanimously agreed, if Dr. Miller's nomination is approved by the Faculty Emeritus Committee and the process respected, they would like a motion drafted and presented to the full board for approval.
