We can sit down and talk about how we program with very few dollars. It's going to be a very ugly year for programming next year. It's very difficult when you don't have money.



Rep. John W. Olver (D-First District) announced today that he will join students, faculty and administrators in holding a rally at Westfield State College on the steps of the Ely Building at 3:30 on Monday to protest proposed Republican cuts in student financial aid.

"In Newt Gingrich's America, these Republicans will cut financial aid that students from hard-working families require to get an education," Olver said. "At state colleges like Westfield, this means hundreds of students might lose their aid."

The rally will begins Monday at 3:30 in front of the Ely Building.

Republicans in Congress have proposed to cut more than \$12 billion over five years in college assistance by eliminating or restructuring four aid programs. On the chopping block are Stafford Loans, Perkins Loans, College Work Study and Supplemental Education Opportunity Grants (SEOG).

Currently, students are able to defer payments on Stafford loans for 6 months after graduation. Under the new proposals, interest would begin to accrue immediately. For the # students at Westfield State who received Stafford Loans last year, the proposal would add # to the cost of going to school for four years. Perkins Loans would be eliminated entirely. Last year, students at Westfield State received over ## in Perkins Loans.

The GOP's Contract on College Students: An Analysis of the Republican's Proposal to End Aid to College Students

As the Republican-controlled Congress considers legislation to cut taxes for mostly the wealthy while balancing the budget, Newt middle and working class Americans.

One of the areas of the federal budget that is virtually certain to sustain drastic cuts is college assistance. In fact, the Republican Congress has already proposed slashing billions by eliminating or restructuring four college aid programs: Stafford Interest-Deferred Student Loans, Perkins Student Loans, College Work Study, and Supplemental Education Opportunity Grants.

In total, the Gingrich proposal will add nearly \$13 billion to the cost of going to college for American students over the next five years.

Stafford Loans:

The GOP proposal eliminates the interest-deferred Stafford Loan program.

Currently, a low or middle income student may take out a guaranteed student loan for as much as \$5,500 in a year to pay for college tuition. The interest on that loan is deferred until 6 months after graduation. Under the Gingrich plan, interest would begin accruing on the loan immediately.

In 1994, the Department of Education approved 4,542,000 student loans totalling \$14.758 billion. The typical loan was for \$3,240.

- ** The Gingrich plan will add \$9.6 billion to the cost of going to college over the next five years.
- The Gingrich plan costs the typical student \$4,344 in added
- The monthly payment for this student would increase from \$153.36 to \$189.56 -- an additional \$36.20 in payments every month for ten years.
- 75% of Stafford Loans were awarded to families with incomes ranging from \$12,000 to \$60,000.

Many students take out the maximum student loan each year. The maximum loans are as follows: freshman = \$2,625; sophomore = \$3,500; junior = \$5,500; senior = \$5.500

- The Gingrich plan costs a student taking out the maximum student loan \$5,274 in added repayments.
- The monthly payment for this student would increase from \$202.65 to \$245.60 -- an additional \$43.95 in payments every month for ten years.

The Gingrich plan is a hidden tax increase for the 4.522 million students who take out a student loan each year. For a student that takes out the maximum loan, the added repayments from the Gingrich plan completely offset eleven years' worth of a child care tax credit to offset Newt's student loan plan for the typical student.

Perkins Loans:

The GOP proposal eliminates the Perkins Loan program.

College Work Study

The GOP proposal eliminates the College Work Study program.

The Work Study program provides federal dollars to colleges to hire low and middle income students for campus jobs like teaching assistance and office support. For every three dollars the federal government contributes, the college must put in one dollar.

Last year, 747,485 students earned on average \$1,098 through the Work Study program. The federal government spent \$613 million and colleges chipped in \$204 million to pay for the program. Without the federal match, it is unlikely that colleges will continue to hire students.

- The end of Work Study will add \$3.0 billion to the cost of going to college over the next five years (not including \$1 billion in college matching funds).
- ** Nearly 750,000 students will lose a Work Study job worth \$1,090 each year.

Supplemental Educational Opportunity Grants (SEOG)

The GOP proposal eliminates Supplemental Educational Opportunity Grants.

SEOG is a direct grant program that goes mostly to low income

Last year, the federal government spent \$577 million on SEOG for 931,603 low income students, who received on average \$827.

Eliminating SEOG will add \$2.9 billion to the cost of going to college for the poorest students in America.

Pell Grants

The GOP proposal increases Pell Grants.

Pell Grants provide money to mostly low income students to help pay for college. 91% of Pell Grants went to students from families earning less than \$30,000 -- 41% with less than \$12,000 in income. Last year, the federal government spent \$6.95 billion on nearly 6 million Pell Grants. The average Pell Grant to a student going to a

The GOP plan takes half the savings from SEOG, Work Study, and Perkins Loans and applies it to Pell Grants. The total savings equal \$3.3 billion over five years, or a 9.7% increase in Pell.

The added funds would increase the number of Pell Grant recipients by 86,951 per year.

Currently, students are able to defer payments on Stafford loans for 6 months after graduation. Under the new proposals, interest would begin to accrue immediately. 
