Dr. Applbaum also informed me that the Health and Wellness Center will cost approximately \$500,000 with \$50,000 - \$75,000 coming from state funds, \$30,000 from alumni donations, additional funds will come from savings and students <u>may</u> be asked to carry the rest with additional fees.

- K. Ted Christ, Cynthia Pucillo and I will be student representatives on a Committee chaired by Dan Forster to work towards changing the current Sign In Policy. We will be meeting on February 9.
- L. The rumor that the workout rooms in all of the Residence Halls are to be removed has resurfaced. Members from within the Department of Residential Life have notified me of this rumor. I will be speaking with Curt Robie to find out exactly what is going on and how this issue, if true, can be resolved.
- M. On February 7 the Department of Residential Life announced, through the Dickinson Hall Council, that they will be hiring a Westfield Police Officer to patrol the halls of Dickinson. The decision to do this was made on February 7. There was no Residential Life representation at these Dickinson Hall section meetings until 8:30 p.m. (the meetings began at 7:00 p.m.). I, personally, agree with the goal of limiting damage within the hall, however, I do not agree with the means in which this is being accomplished. I have asked for Residential Life to consider delaying the implementation of this, however, it does not appear that this delay will happen. Apparently the Police Officer(s) will be patrolling the building beginning on February 10 (Thursday, Friday and Saturday night) and will continue to do so until Spring Break. At that time, the situation will be reassessed and the decision on whether this will continue will be made:

The following dialogue is an adaptation and statements may be paraphrased.

- 1. Kevin Cross What was the reason for placing Police Officers in Dickinson Hall?
 Jon Conlogue This is a very strange situation. The situation in Dickinson is unusual in regards to damage and disrespect. We've had meetings with the R.A.'s, Hall Council, Sections, etc. Things need to be done immediately. Some ideas we had were increasing Campus Police, ISO rounds outside Dickinson, increased Student Security and increased Residential Assistant staffing. There is no way that ten people can control 300 people. If an R.A. is dealing with one situation, they can't deal with another situation. They can't deal with another situation that is occurring at the same time.
- 2. Tricia Rocco What other alternatives have you considered and who made the final decision? Jon Conlogue - I told George Sicaras to go ahead and explore it. Options were discussed with Hall Council also. Tricia Rocco - So, all of these alternatives were discussed and you decided to go with the Westfield Police Officer? Jon Conlogue - All of these things are and will be done.
- 3. Jen Salmon Why didn't you try increasing Student Security? Jon Conlogue We did. At the end of last semester we

increased Student Security inside the building.

- 4. Amy Corcoran Last year when Freshman Halls were being discussed, there was talk of implementing a Freshman Seminar. What ever came of it? Kathi Bradford - We had hoped that since so many organizations had concerns with the necessity of a Freshman Seminar, that one would be implemented.
- 5. Lori Potter I think you should consider what people will think, especially parents, when they send their children to halls that are policed. Jon Conlogue - I agree that it could have a negative effect but on the other hand, so would vomit and broken beer bottles all over the bathrooms.
- 6. Tom Stewart It is a terrible waste of personnel not to utilize the ISO's. There's your solution. Have the ISO's do rounds. Perhaps they need to be retrained. Ted Christ As far as the R.A.'s go, the current training is not sufficient. The R.A.'s need to be better prepared to deal with these situations.

 Jon Conlogue I think it is completely unfair for R.A.'s to be blamed for the resident's conduct. For students to say they didn't know the policy, I'm sorry, that doesn't cut it any more.
- 7. Yvette Edwards I don't blame the R.A.'s. I blame the training. If you're going to have Freshman Halls, you have to have more intense training for the R.A.'s. Secondly, if you're going to have police patrolling the building, why do you need an ISO and R.A.'s?

 Jon Conlogue The Police will be in Dickinson on Thursdays through Saturdays from either 9:00 p.m. 3:00 a.m. or 11:00 p.m. 4:00 a.m. in the lobby. They will accompany R.A.'s and Student Security on their rounds.
- 8. Yvette Edwards Have you already had Student Security going around the building? Dave Gallagher - We aren't allowed to go through the building unless specifically asked by ISO's or R.A.'s.
- 9. Professor Tetrault I don't want to see the R.A.'s blamed but I think they should be blamed as well. Blame is on the people who train the R.A.'s too. Distribution of the blame should also be placed on the Admission's Office. How in God's name did these students get here? Tell the Westfield Police to get their overtime somewhere else.
- 10. Vice President Mazza We have confronted several problems working in concert with Faculty, Student leaders, R.A.'s. I invite several leaders to work with us. I think if we put our minds to it, we can come up with a solution. I reinvite us to tackle this and other problems with the idea of social responsibility. I will provide my support and effort.
- 11. George Sicaras Our job is to provide safety and security. Dickinson Hall is a real problem for us. Westfield Police

- were chosen because we are short staffed. One solution may be to put a Westfield Cop on with a Campus Police Officer to do rounds in Dickinson.
- 12. Ted Christ Would you put off having the Cop present this weekend so we could look at other alternatives? Jon Conlogue - Absolutely if I can get a commitment from this group.
- 13. Karen Guistina It seems like every idea we give to Residential Life isn't taken into serious consideration. Are you willing to look at our alternatives? How many people have been kicked out? Jon Conlogue - I do think we have tried a lot of things suggested by SGA, i.e., Sign In Policy, Fire Doors. I don't know how many students they have kicked out. We refer students to the Judicial System. In the end we have no control over what happens.
- 14. Dave Kroon People are not going to react well to uniformed Police Officers in the Halls. We're trading liberty for order by bringing in Cops.
- 15. Jim Godfrey Have you found out the cost?

 George Sicaras \$16.00 per hour for four hours.
- 16. Jim Godfrey Have you or anyone from Residential Life actually witnessed the damage at Dickinson? Jon Conlogue - I have been in Dickinson on several weekend nights.
- 17. Erik Whynot How many cases have you referred to the Judicial Board? The J-Board has heard less than one percent of those cases. Obviously, something is wrong if we're not hearing any of these cases about the damage in Dickinson.

 Jon Conlogue One single problem with vandalism is that it is anonymous. Much of the damage is anonymous.
- 18. Erik Whynot What exactly is the role of this Police Officer? What actual functions will he have? Jon Conlogue - The roll of the Police Officer is still being worked out.
- 19. Dan Szenda We have a Student Conduct Handbook and if we used it properly, it works well. You just can't kick students out.
- 20. Yvette Edwards Why was Hall Council responsible for explaining Residential Life actions? That burden should not be on the Hall Council. Jeanette didn't even show up until 8:30 p.m.
 Jon Conlogue I agree with you. The problem was that the meetings were scheduled when Jeanette had a class.
- 21. Pauline Kerbici As a resident of Dickinson, I heard what you had to say but I don't know if you heard what we had to say.

 Point of Information: Jeannette did know about the times of our meetings.
 - Jon Conlogue With regards to your first point, I did ask Hall Council if they had any other suggestions. They came
