- I. <u>ROLL CALL</u>: Nikki Pugliese, Sean Kelly, Tricia Rocco, Janice Murphy and Kristen Glynn were absent. Kevin Cross, John Dolan and Kim Shea were excused. Jen Jeffrey sent an alternate.
- II. APPROVAL OF MINUTES OF MARCH 8, 1994: The Minutes were approved.
- III. PRESIDENT'S REPORT: Ted Christ
 - A. Constitution Committee: Ted Christ
 - 1. Ted Christ moved to suspend Parliamentary Procedure. The motion was accepted. There was discussion on ratifying new changes to the existing SGA Constitution. Ted Christ moved to reinstate parliamentary procedure. The Motion was accepted. Bryan Walsh moved to tentatively approve the SGA Constitution. Ted Christ moved to amend the motion so that the Constitution include changes discussed. The Motion to amend was accepted. The Main Motion stood on the floor that SGA tentatively approve the Constitution with amended changes that were discussed. The Motion was accepted with two abstentions (Amy Corcoran and Jim Godfrey).
 - B. Ted Christ recognized George Sicaras who discussed the arson in Dickinson Hall in February and the arrest of Gregory J. Glynn. Gregory has been charged with attempted arson (ten year penalty) and illegal placement of an explosive device (thirty year penalty). This matter has been referred to Vice President Mazza for the appropriate administrative action:

The following dialogue in the President's Report is an adaptation and statements may be paraphrased.

 Jen Corsac - Did anyone receive any reward for giving information leading to the arrest of the arsonist? George Sicaras - We're going to pursue that. I think the person who gave us the most information may be able to get all or some of the money.

George Sicaras then discussed the issue of security and the Agawam Police who are present at the Senate Banquet:

2. Ted Christ - Will the College alcohol policies be taking precedence over the Agawam police procedures?

George Sicaras - I hope that College policies prevail. I want to get that ironed out beforehand. No, our policies do not take precedence over law in the town of Agawam.

Tom Stewart - From my personal experience working with the Agawam Police at the Banquet last year, I know that they don't go looking for arrests. They're not looking to nail you. We try to avoid putting the police in the position where they have to make an arrest.

George Sicaras also informed SGA that there will be a Disciplinary Hearing at the end of March for an Officer that did not treat individuals on campus in a professional manner.

C. Ted Christ recognized Debra Tynes and Ann Marie DiMartino who spoke to SGA about the newly formed Student Support Services Program. The mission or primary objective of the Student Support Services (SSS) program at WSC is to provide appropriate services to eligible students in order to retain them to graduation. The program will provide a support network of workshops plus academic, interpersonal and career advisement offered by faculty and staff experienced in program planning, implementation, instruction, counseling and evaluation:

- Ted Christ Is this a relatively new program and have you
 done any advertising especially in the Freshman Halls?

 Debra Tynes It is a new program. The grant came through
 in early November. This is the first semester it has really
 been underway.
- Ted Christ How long is the grant for?
 Debra Tynes Four years.
- Erik Whynot Are you working in conjunction with Urban Ed?
 Debra Tynes We're working closely with Urban Ed.
- 4. Erik Whynot Are you going to be working with the summer program?
 - Debra Tynes Yes. We'll be here in the summer as well.
- Yvette Edwards Are you open to the entire campus?
 Debra Tynes Yes. We are available to all matriculated students.
- 6. Bryan Walsh What are your hours? Debra Tynes - The four instructors are here after 3:30 p.m. The Counselor and Coordinator are here full-time.
- E. Faculty Evaluations are going well. Please keep working on them!
- F. SGA is now officially handling Fund Raising Proposals for all SGA recognized groups as well as other student groups on campus whose request will not exceed \$1,000. Please contact Jen Salmon for more information on this.
- G. Ted Christ asked for two Senators to be representatives on the newly formed President's Committee on Diversity. Lori Potter and Angela Nydam were appointed for this Committee.
- H. Ted Christ discussed the article which appeared in the Union News Westfield Edition over the spring break regarding faculty concern over incidents of verbal abuse/threats. Ted has spoken to Dr. Davis Chapter President of the Faculty Union as well as Dr. Stakenas in order to obtain more information on the justification and necessity of establishing a policy protecting faculty members from incidents of verbal abuse/threats:
 - 1. Erik Whynot Why do we have to have a policy dealing with student threats against Professors? Couldn't a Professor simply obtain a restraining order or file a complaint with the police?
 - Ted Christ Right now there is a policy called the Code of Civility and Courtesy. Dr. Davis wants to bring this further and make it more stringent.
 - Dave Gallagher Can I recommend that a similar policy be discussed as well for the Professors' behavior. Ted Christ - I'll convey that to her.
- Ted Christ encouraged students to take a stand on the proposed Commencement Fee increase. This one-time fee paid upon matriculation

Once a student has earned 54 credit hours, he or she may not be removed from the major department.

This issue will be considered further at the April 5 Meeting as well.

- g. Amy Corcoran Once you are removed from your major, how do you get back in? Steve Pratt - This is only for competitive majors. It's up to the respective major department.

WHAT IS THE STUDENT SUPPORT SERVICES PROGRAM?

The primary goal of the Student Support Services (SSS) program is to provide appropriate services to students in order to retain them to graduation. Another focus is to help prepare students for acceptance into graduate and professional school. The SSS program provides a cooperative learning environment for workshops in Math, Science, English as a Second Language, Critical Thinking in Reading and Basic Writing. The activities are designed to give students the basic skills needed to excel in college courses. Counseling is also provided to assure that program participants are given direction and support.

WHERE IS THE PROGRAM LOCATED?

The program is located in Room 235 of Wilson Hall on the campus of Westfield State College. The program shares physical space with the Urban Education and Disabled Students program.

WHY SHOULD I PARTICIPATE IN THE PROGRAM?

One of the main focuses of the SSS program is to help students excel in college and enhance their opportunities for successful graduate study. The instructional objective is to identify a student's needs and develop a curriculum to address those needs. The program can be an effective tool in ensuring a student's success in college.

WHO IS ELIGIBLE FOR THE PROGRAM?

The SSS program primarily serves students who are: first generation college students, students who demonstrate financial/economic need, and those who are physically challenged or learning disabled. The SSS program counselor or academic coordinator can determine if you qualify.
