  - a. Erik Whynot I don't know if everyone fully understands how much time it takes to go to Lammers and all the way around. It takes just as long to walk to Courtney. Lammers is another ten yards.
  - b. Kerri McQueston It doesn't make any sense for a girl to stand in South Lot for twenty minutes or in front of the Dining Commons. It's the same thing.
  - c. Greg Kanevski We changed the route because of daylight savings. If you want us to go behind Lammers, we can do that. It's a difference of a changing a fifteen minute route to a twenty minute route. The van only gases once a day now. They service Davis, Scanlon, the Apartment Complex, a portion of Ely and the Dining Commons. If you have a special request, we will have the shuttle van drop you off. We will do whatever it takes. We need to know what you want to do.
  - d. Karen Guistina There is a difference between South Lot and the front of the Dining Commons. If you are dropped off at the Dining Commons, there are buildings all around you.
  - e. Kevin Cross Why was the route last year that went behind Lammers and Courtney stopped? I thought it was very successful?

    Greg Kanevski The vans drive over one hundred miles a day, seven days a week. The wear and tear from going behind the building and the fire alarms, it's just not the safest route to take.
  - f. Kevin Cross Even when we have a new van?
    Greg Kanevski Those vans were only two years old.

- g. Tricia Rocco Can we ask that there be a standing policy that if someone asks that they be dropped off at Lammers, it will happen?

  Greg Kanevski We can do that. If you have 350 people in Lammers who want to be dropped off at Lammers, it's just as easy to change it.

  Tricia Rocco I was thinking more about at night.
- h. Kristin McQueston Why don't they just incorporate Lammers into the route so everyone gets dropped off where they want to go?
- i. Jim Godfrey Five minutes is a long time if something is happening down there. The shortest amount of time that people have to wait is a preventative measure.
- j. Brian Person If we announce that we are getting gas, someone who has a scanner may pick up on it and that's when cars get broken into. If people ask, we will cut the route to make you happy.
- k. Dave Kroon How much would another van cost? Greg Kanevski - We did budget for a second van. Whether there is money or not is not my decision. It's another idea that will be looked into.
- 1. Dave Kroon Have you looked into how much another van would cost to operate? Greg Kanevski - \$20,000 for the van; staffing and the cost of maintenance would probably be around \$700.00 per week.
- m. Maegen Moore Where would you be waiting if the van goes to Lammers instead of the Cafe? I'd rather be waiting by the Cafe then behind Lammers. Greg Kanevski - It's up to the students where you want to meet.
- n. Tricia Rocco If you read your Handbook it says that if you're getting picked up in South Lot, sit in your car with our lights on and wait for the van. Don't be stupid, don't get out, stay in your car!

The majority voted not to change the shuttle van route.

Statement regarding the five year Capital Planning Program for Higher Education. Secretary of Education, Piedad Robertson, asked that the document be received by the Committee for further consideration. This would have allowed for a refinancing of debt on the State College Building Authority at a substantial savings if done with the whole plan. The Committee decided against receiving the document due to the insufficient amount of information in the document. The Secretary was very upset by the decision and the accusation that the list of projects was not complete or representative of some college's recommendations.

- 2. Through this statement for Capital Planning, deferred maintenance would be paid for through some sort of fee structure. The 14.5 million is part of a total package which would have students paying fees over a 30 year period of time:
  - a. Chris Sault Shouldn't we set a precedence if WSC is paying for the turf? Dan Szenda - In a way we did and I brought that to the student member of HECC. That's going to work against you but as far as other things go, there are other buildings on the campus that are different in nature to an Athletic Complex.
  - b. Amy Corcoran The Chancellor said that he is not in favor of students paying for deferred maintenance or capital projects through tuition or fees. The memo says that we may pay anywhere from \$46 \$72 per semester for these projects that the Chancellor says he does not want to support. How is HECC going to attack this? What action are you taking? What specifically do you want us to do?

    Dan Szenda As far as contributions from students, it's in the neighborhood of \$100,00. Right now we're paying \$50.00 a semester for an Athletic Complex. That is \$1.5 million in bonds. What we have right now is a \$14.5 million package. The way the Secretary presented it, it's a take it or leave it kind of situation.
  - c. Erik Whynot It sounds like a can't win situation. What are you suggesting we do? What other options do we have?
    - Dan Szenda The best thing that we can do is to get all the campuses in the State and Community College system informed about what is going on. Find out all of the information behind both sides of the issue. Until you know both sides, you can't make an accurate decision.
  - d. Kathi Bradford Isn't is true that of that money, half of it would be paid for by students? Aren't we in a situation where some buildings on campus may be shut down if renovations aren't done? Dan Szenda - If the renovations aren't done, and there

- isn't an emergency fund, you could go to your Legislators and find out how we can lobby to get the money.
- e. Ted Christ Keep in mind that this year alone we're looking at a campus center fee, a career service fee, a graduation fee, a fitness fee and a renovation fee. That is almost \$200.00 in increases in one year. Is SAC working on any kind of demonstration that State College students can participate in?

  Dan Szenda That is going to be up for discussion at the November 18 SAC Meeting. First we must get as much information as possible so we don't go into the meetings unprepared. Then we can come up with a plan to combat this. That's something we can do through SAC at the December meeting.
- f. Dave Kroon I think the time has come for students to have their voices heard. We've got to go to Boston and let them know that the students are here. We know what is going on and we don't like it.
- g. Lori Potter Is there a way the SGA can draft a letter to the Secretary of Education expressing that the way she acted was not appropriate? Dan Szenda - We will do that through SAC.
- h. Chris Sault If we didn't pay the \$50 for the turf, where would the money come from. Dan Szenda - We wouldn't get it.
- i. Chris Sault There was no problem getting money for the turf except for the Referendum. There was no problem getting the turf money but we can't get the academic money. We're going to look bad if all we want on campus is luxuries and not academics.
  Dan Szenda I understand what you are saying. You're worrying about how it looks. There are already two State Colleges in the system that have already taken a reserve for capital planning which means they've already got millions of dollars in reserve. There's a lot of things to consider when we do this and that's why if we have a rally in Boston, that everybody knows
  - Dave Gallagher If you do hold a rally, cover every exit.

what's going on.

- j. Tricia Rocco I think we should have a rally on campus first. Have a rally here so we can educate the students and then take them to Boston.
- k. Amy Corcoran How are you and SAC planning to inform the campus of this and when? What is your timeline? Dan Szenda - As far as getting this out to the constituents, I want to get as much information across at our meeting at STCC on November 18 and get input there and bring the information back to the campus.
