

## STUDENT GOVERNMENT MINUTES

- I. ROLL CALL: Kim Harper, Bryan Walsh, Keely Bethel, Erik Whynot, Tom Burke, Kerrie Carnes and Scott Ross were absent. Craig Colby and Maegen Moore were excused.
- II. APPROVAL OF MINUTES OF NOVEMBER 23, 1993: The Minutes were approved with two clarifications.
- III. PRESIDENT'S REPORT: *Ted Christ*
  - A. Cable Committee: *Ted Christ*
    1. I have received information about the Federal Cable Regulations from Representative John Olver. I am in the process of reviewing this information. I have also put a call into Steve O'Neill from Continental Cablevision and am waiting to hear back from him.

  - D. I need two students representatives for the Affirmative Action Advisory Committee. Their charge will be to review personnel selection processes to ensure fairness.
  - E. With respect to the numerous fire alarms. A monetary reward of \$1,000 will be given to any student leading to the conviction of an offender. SGA is slated to contribute part of the money for this reward. Do you feel that SGA should be funding this reward or should the school be funding it entirely? Currently, \$500.00 will from the Facilities and Operations Department, \$250.00 from Residential Life and \$250.00 from SGA.
  - F. SGA will be conducting a Survey through Steve Dailey in order to evaluate the feelings of students regarding the proposed Health and Wellness Center. We are hoping that the results will provide us with a reference of how the student body is feeling about this issue.

I want to be better informed about what areas are in violation and need capital funds to be repaired/replaced. During a meeting, Curt Robie told me the school could possibly be in danger of being closed down if we do not correct certain violations of state building codes.

  - I. I will be attending the Long Range Planning Committee Meeting on December 8 to discuss space reallocation in Ely.

**Diversity Requirement**

The goals of the diversity requirement are to help students understand and appreciate the similarities and differences among humans and to explain the nature of civil and human rights.

Two diversity courses would be required of all students.

**Standard:** The first category of courses would have as their major content, or relate in a significant way to, civil and human rights issues in the United States. The second category would include courses which help students to understand the complexities and the interdependence of our global community.

Specific goals of such courses might include:

- a. analysis of public policy issues, e.g., gender bias, racism, censorship, poverty, and other civil and human rights problems;
- b. identification of the historical roots of contemporary issues;
- c. understanding of cultural aspects of public policy and global issues;
- d. discussion, orally and in writing, of alternative

viewpoints on these issues;

e. identification and evaluation of possible courses of action toward resolving these issues (wording here proposed by Carabetta and Tatum).

2. Amy Corcoran - Are these courses available now at WSC or are they going to be instituted? Second, who are they going to get to teach these courses? It seems that we have a shortage of professors for the courses we need now. Third, would these courses be in addition to everything we have to take now? Will this be included in the double-dipping?

Dave Kroon - Some of the courses are currently here. The rest would be prepared by individual departments and then submitted to Curriculum. They would approve or disapprove of them falling into this category. Second, as far as faculty, there are several qualified to teach these courses. Additional faculty may come from courses they may be eliminated. Assuming that double-dipping is approved, there will be some double-dipping.

Dave Kroon - That is not specified. That would be determined by the Committee or the department.

Dan Szenda - The first step is to write a letter to Academic Affairs. If you have any concerns about the people on the list, I hope you would give them to me and I will bring them up in the meeting. It is very important that I be your voice in the matter.

- c. Dave Gallagher - Does the Board of Trustees take the Faculty Evaluations currently done into consideration and does it play any factor at all in whether they get tenure or tenure track?

Dan Szenda - Yes and No. It is factored in but I don't see it as a large factor in the whole process.

Dave Gallagher - So then basically the Faculty Evaluations which are done have no point.

Dan Szenda - I wouldn't say absolutely no. I'm not trying to put too much emphasis on what is actually given. That may be largely due to the Evaluation itself.

Ted Christ - They do play a part; we just don't know how much of a part. That's why we're working on new Faculty Evaluations.

- d. Bryan Walsh - Where is that meeting?

Dan Szenda - In the President's Board Room. If anyone is interested in going to sit in on it, see me at 5:00 p.m. on December 6.

2. *Kevin Cross* - People could work out in Scanlon and shower back in their Residence Halls.

*Laura MacWhinnie* - We're trying to create a Wellness Center. Ted's proposition is for a room with weight equipment. That's not a Wellness Center. It is not an option to put it in the Scanlon Activities Room. It needs to be supervised and there needs to be a shower.

3. *Amy Corcoran* - In addition to the extra fee added to the bill, will there be an additional fee to use the Wellness Center?

*Laura MacWhinnie* - It is proposed, at least by my Board, that the increase in the Trust Fund is the only thing that you'll be paying. That will allow you to use the facility. You would not have to buy a membership to a gym.

4. *Chris Sault* - Not everyone wants to use a Health and Wellness Center. It's just like cable, not everyone wants to watch TV. If it's so easy to tack this fee onto our bill, then why don't we have cable?

*Laura MacWhinnie* - Keep in mind that \$40.00 is just a random number. It is not finalized. We've been polling a lot of people and the majority of those people have a gym membership. The majority of students are athletes. They work out. We're trying to find out how many people want it and how many don't.

5. *Steve Pratt* - You said a lot of people have expressed interest in the Wellness Center because they go off campus to work out. It would seem to me that as many people, or more, go off campus to drink. That would seem to be a reason not to get rid of the Owl's Nest. Is there any way that we can inform students of what's going to happen?

*Laura MacWhinnie* - There are a lot of people who drink off campus because the majority may be underage and can't get into the Owl's Nest. The Owl's Nest is offering cheaper beer. What the Wellness Center would end up doing if offering a Wellness Center at a cheaper cost than what you're paying at an off campus place.

6. *Karen McManus* - We already have a lot of fees coming up. Can your Board keep in mind that we have intramural aerobics, we have a swimming pool and a racquetball court. I think we should put the gym in Scanlon. They don't have to all be in one location.

*Laura MacWhinnie* - We are taking the fee into consideration. We won't make that decision until everyone is going to benefit from it and the fact that everyone is going to have to sacrifice monetarily, we're going to be very cautious of that.

7. *Dave Gallagher* - Keep in mind that if this fee is assessed, eventually they are going to hit us for half of the \$14.5 million. If this sets a precedence, they will say that

they accepted \$40.00 for a Wellness Center, lets assess them \$7.5 million for a new building. Let's keep that in mind!

8. *Andy Johnson* - We have absolutely no intention of putting through a fee increase for students until we come down here and make a proposal to SGA. If you people do not accept the proposal, then I strongly doubt it will go anywhere. The Campus Center has never put through a fee increase that the SGA has not supported.

9. *Dan Szenda* - Who is on the Owl's Nest Committee?

*Suzy Cook* - *Andrea Wynn, Shelley Ryan, Karen Kirby, Christina Meriano and myself.*

*Dan Szenda* - With a new contract in the works for Food Services, we have to examine what can be offered, variety of beverages, hours of service, over and under events, etc. What we need to do is to make sure that issue isn't at all sidestepped.

10. *Laura MacWhinnie* - The Committee is still dealing with present issues. They are not going to neglect the Owl's Nest. I've talked to Andy about changing the hours and starting next semester they will be trying 9:00 p.m. - 1:00 a.m.

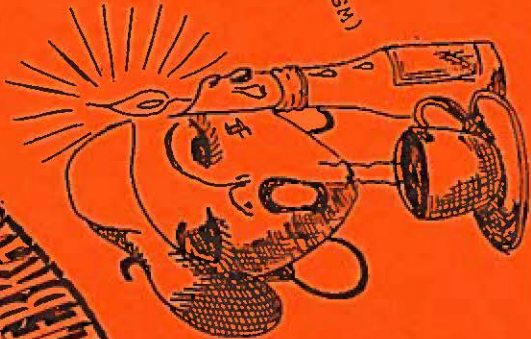
