III. PRESIDENT'S REPORT: Ted Christ

- A. <u>Cable Committee</u>: No Report
- B. Conference Selection Committee: No Report
- C. Constitution Committee: Ted Christ
 - The Constitution Committee discussed membership on this ad hoc Committee and also reviewed the structure of the SGA Constitution.
- D. Ted Christ recognized David Bannish and Richard Sullivan, candidates for Mayor of Westfield, to speak about their respective campaigns. David Bannish said that he would welcome help from students on his campaign during the final week before the November 2 election. He left a sign up sheet in the SGA Room if anyone is interested.
- E. Ted Christ recognized Laura MacWhinnie who addressed SGA regarding the two Confederate Flags which were displayed in windows in Lammers Hall:
 - 1. Laura MacWhinnie Being aware of the general meaning of those flags, I felt that it was my responsibility as a student to confront the owners of the flags about the issues and feelings being expressed to me by members of the college community surrounding their actions. Accordingly, another student and I attempted to contact the two students but were unsuccessful. Therefore, we approached Dan Forster who told us that one student had already been spoken to and that the second student was not in the building. At that point, we left Dan's office with the understanding that he would later speak to him. In short, the flags were removed by the end of the day. Unfortunately, the flags have been returned to the windows and now it is necessary to address this matter publicly. The purpose of this speech to you is not to argue First Amendment freedoms of expression. Τ am perfectly aware of individual rights as well as the legal limits of those rights relative to society. In fact, the United States Supreme Court case, Street v. New York (1969) overturned a conviction of a protestor who was found guilty of burning the American flag. In 1989, the S.J.C. reaffirmed the Street decision in Texas v. Johnson, when they protected Mr. Johnson's right to burn the flag as a form of symbolic speech. Essentially, flags are more than "cloth and design," they represent ideas and evoke feelings. Historically, the confederate flag has symbolized the racist ideology professed by white supremacists. At meetings or group gatherings they display two symbols; Swastikas and the confederate flag. These symbols represent white superiority, oppression of

racial minorities, anti-semitism, and a history of brutality against blacks during slavery and during the Civil Rights Movement. The displaying of these flags must be recognized as a form of **Hate Speech** and as such, the college administration must make a positive reaction in accordance with the Policy of Racism outlined in the Student Handbook.

- 2. Kevin Cross Laura, have you spoken to them? Laura MacWhinnie - I haven't spoken to them a second time. One is led to speculate their motives after a second time. They were approached on a peer level, they have dealt with their R.D., Dan Forster. It is going through the hierarchy.
- 3. Dave Kroon What the flags represent to the students hanging them from their windows should be taken into consideration. Laura MacWhinnie - I don't expect SGA (I would hope), but I don't expect you to support me on this.
- 4. Meredyth Leahy The fact is that the flags are hanging in the windows for the campus to see. If they were just hung in the rooms, would that make a difference? Laura MacWhinnie - It makes a compromise of his rights. It's different then a newspaper which I can choose to look at. I would accept a compromise.
- 5. Dave Gallagher Whether or not they are racist, these students have every right in their First Amendment to display them. What right do you or Dan Forster have to stomp on their rights?

Maria Garcia - I absolutely agree with you. Kevin Cross - Let's find out what these guys feel first. Laura MacWhinnie - They will have a chance to respond. They had a chance to respond to their R.D.

- F. Chancellor Stanley Koplik will be visiting WSC on November 9. Dr. Applbaum has asked that I consider recommending student leaders to meet with him. Anyone interested in meeting Chancellor Koplik, please see me after Senate.
- G. Vice President Mazza has expressed his concern over the quality and production of the Yearbook. The Executive Committee has discussed this and Jen Salmon will be examining this issue for us. Funding for the Yearbook is secured from her office.
- H. Vice President Mazza and Maureen McCartney, Director of Career Services, have proposed a fee increase to help with the extensive demands of Career Services. I will be meeting with Maureen McCartney on October 29 to further discuss this matter.

<u>Progress Report on Current Proposed</u> <u>Changes to the Common Core of</u> <u>Westfield State College</u>

Dave Kroon October, 1993

I. Introduction

The common core of Westfield State College has not been revised since 1974. During the twenty years since the last revision, both WSC and society have undergone many changes. In light of this, ACC decided the core should be revised.

The Curriculum Committee was handed that charge over a year ago. In that time, the committee has been hard at work to put together a proposal that will provide the best possible education for students, but keep the proposal within reason from the standpoint of both the faculty and the institution's resources.

It is important that the reader of this document understand the fact that all the additions outlined herein are tentative. Some of these changes will be in the final proposal, and some will not. Furthermore, some of the outlined changes will have a very different look and meaning when they are included in the final proposal. The purpose of this document is to help the reader in keeping abreast of what the committee is doing, as well as to clear up any confusion or misconceptions.

II. OVERVIEW

The proposal as it stands as of this writing, includes the following requirements. Note that the total number of hours outlined here does not necessarily represent the total number of hours that will be required of the student. For more information on the work being done in those areas, refer to <u>double-dipping</u> and <u>area exemption</u>.

D) History/Government

The History/Government requirements will not change. Each student will be required to enroll in three credit hours in this area, currently listed on the back of the Course Offerings Booklet as "State and Local Government." NOTE: three hours in this area are required by law.

E) Social Understanding

The Social understanding requirement will not change. Each student will be required to enroll in nine credit hours in this area, currently listed on the back of the Course Offerings Booklet as "Social Understanding."

F) Mathematical Reasoning

Each student would be required to enroll in six credit hours in the Mathematical Reasoning section of the core, currently listed as "Mathematical Reasoning" on the back of the Course Offerings Booklet.

G) Science

Each student would be required to enroll in two science courses, one of which would be a lab science, for a total of seven to eight hours in this area (lab sciences are always four credit hours). This section is currently listed as "Analytical Science Section" on the back of the Course Offerings Booklet.

H) Diversity

Each student would be required to enroll in a total of two "Diversity" courses, totalling six credit hours. There are

latitude in these requirements, due to the vastly different student needs and abilities.

J) Upper Level Requirements

Each student would be required to enroll in three courses for a total of nine credit hours in this area. The purpose of the area is to broaden the student's liberal arts education in breadth as well as depth. By this the committee means that students should obtain some degree of competency in areas outside of their major. It was not felt that this competency was achieved through the current 100-level requirements. The three general methods in which the committee sees this issue as being implemented are as follows:

1) Menu Option-

Under this option, the student would be required simply to enroll in any three upper-level classes outside of his or her major area.

2) Course Designation Option-

Under this option, each department would have certain upper-level courses designated as those that fill this requirement for non majors. Each student would be required to enroll in three of these designated courses.

3) Hybrid of options 1 and 2-

Under this option, students would be required to enroll in one course from a list of designated upper-level courses, and any two of their choice (outside their major area) or vice-versa.

student receives credit for the course only once, but the course can be applied towards more than one area. As an example, if a student enrolled in a course titled "African-American Writers," that course could fulfill both a literature requirement as well as a diversity requirement.

B) Area Exemption

This means that a student would not necessarily be required to fulfill the core requirements within their major. For example, a music major might not have to fulfill the "Fine Arts" requirement of the core.

IV CREDITS

Thanks and credit must be extended to Dean Martin, professors Averitt, Savini, Welch, and students Theodore Christ and Angie Nydam. Their assistance in putting this outline together was invaluable.
