- I. ROLL CALL: Alex Rossi, Tami Massa, Linda Stake and Tony Amica were absent. Maegen Moore, Tricia Rocco, Kristen Legor and Craig Colby were excused. Chris Hurley sent an alternate.
- II. APPROVAL OF MINUTES OF SEPTEMBER 21, 1993: The Minutes were accepted with corrections.
- III. PRESIDENT'S REPORT: *Ted Christ*
- A. Ted Christ recognized Dr. Hanrahan, Tom Stewart, Chris Mungeon and Andy Johnson who each addressed Senate regarding their being SGA Advisors for the 1993/94 academic year. Ted spoke on behalf of Kathi Bradford who was unable to attend the meeting. Karen McManus moved to accept all five nominees as Advisors. The Motion was accepted with one abstention: Kelly O'Neill. Dan Szenda moved to reconsider the previous question. The Motion was accepted with two abstentions: Yvette Edwards and Jen Dennis. Todd Audyatis moved that all those in favor of accepting all five nominees as Advisors please indicate by saying aye. The Motion was accepted with one abstention: Kevin Cross.
- B. Dan Szenda moved that SGA elect a Parliamentarian. Dave Gallagher was nominated and accepted the nomination. Bob Stone was nominated but declined the nomination. Kevin Cross was nominated but declined the nomination. Todd Audyatis moved that all those in favor of accepting Dave Gallagher as SGA Parliamentarian please indicate by saying aye. The Motion was accepted with two abstentions: Dave Gallagher and Bob Stone.
- C. Ted Christ spoke to SGA regarding a meeting which he had with Kevin Barnard, Editor-In-Chief of *The Owl*. The main focus of the meeting involved an ad which appeared in the Arts and Entertainment section of the September 20, 1993 edition of *The Owl*. Ted said that he voiced concerns over the image that this type of ad would create for both the college and the paper; the fact that the paper is student funded; and that the ad could be offending people. Kevin Barnard said that they are creating an editorial policy and also expressed concerns over this organization. Ted felt that it was a very positive and productive meeting. Ted and Kevin also met with Attorney Rockne Palmer (Attorney on retainer by SGA with student funds) regarding possible repercussions from the ad. Attorney Palmer indicated that *The Owl* can not be censored by Student Government or the Administration but that SGA could consider repealing funding based on their editorial policies. Ted then recognized Kevin Barnard who discussed changes which will be occurring at *The Owl* this year. *The Owl* will occasionally be using colored print (\$75.00 for four pages). The deadline for anything that needs to be published is Tuesday evenings by 7:00 p.m. or submit it to Ginny Gregory who will be reporting the SGA Meetings. Kevin also informed SGA that *The Owl* will be purchasing a MAC LC3 Computer.

1. *Amy Corcoran* - I was wondering how you discriminate between which ads go into the paper and are there guidelines you follow as to what does go in?
Kevin Barnard - We heard a lot of rumors about the ad but we never heard anything from anyone except Ted Christ. Anthony's Pub approached us; we didn't call them. Originally the ad was much more derogatory than what we printed. The policy is that they are a paying client and we will run the ad.
2. *Jen Dennis* - When you get into the SGA setting an editorial policy, you do get into censoring but that ad was in poor taste. Think about where this paper is going and who it's going too.

Kevin Barnard - Yes, there are people who will be offended by ads. It happens all of the time. Take, for example, the gay, lesbian and bisexual ad. Many people took offense to that also.

Laura MacWhinnie - First I would like to touch upon the gay, lesbian and bisexual ad. It is a positive ad. It should not have been used as a parallel to the Anthony's Ad. We give you money to put out a proper paper. I have yet to see that. I think you should put intellectual articles in. I feel that choice was distasteful and in poor judgement. Some of the females on this campus are at a morally impressionable age. Ads like that could make poor impressions.

Kevin Barnard - It's true that there are certain people who are impressionable. The paper is paid for - to a point. We have expanded the paper above and beyond what I thought was possible last year. It's not like we don't care; we do.

3. *Dan Szenda* - What is the cost of *The Owl* per issue and how much have you collected in advertising?
Kevin Barnard - Offhand, I don't have the figures for this year. Last week we made a profit of approximately \$600.00. Any of the advertising revenue will be used for new equipment.
4. *Andy Johnson* - I too am very concerned. I understand the need for more money. Money isn't the issue here. This ad is in poor taste. We need to set a standard higher than legal would allow. I hope to not see an ad like that in the WSC paper again.

Kevin Barnard - I understand your opinion and concern. We understood it would be offensive to some people. It is an opinion issue.

Tom Stewart - We are going to have to learn about the real world. He made a decision and went through with it. He took the proper avenues to do so. I think we ought to commend Kevin.

5. *Jen Salmon* - I'd rather see an eight page paper of newsworthy articles than twelve pages of trash!

Danielle Dube - You're saying that if you had the space for a paid ad or a college announcement, you'd pick the paid ad? That's wrong. We have the right to know what's happening on our campus.

Kevin Cross - Kevin Barnard has apologized, however, *The Owl* needs to advertise to raise money.

Lori Potter - I support your first Amendment right but that doesn't give you the right to lessen integrity.

Kevin Barnard informed SGA that *The Owl* is discussing the possibility of advertising alcohol. The general consensus of SGA was that alcohol being advertised was not what bothered them.

6. *Andy Johnson* - Advertising alcohol how? Glamorizing? Please be more specific.

Kevin Barnard - I don't know how we'll advertise. If someone came to us with an ad saying Busch Lite for \$10.99, we will print it.

Amy Corcoran - Is this part of your Constitution? Are you going through the Rules and Regulations Committee?

Kevin Barnard - Advertising is not part of our Constitution.

- D. The Senator Orientation held on September 26 proved to be very informative for all who attended. Twenty Senators came to learn about the function of SGA and we will leave suggestions for the 1994/95 Executive Council regarding this Orientation.
- E. The Executive Council voted not to recommend acceptance of the second candidate for a position as an intern in the Judicial Affairs Office. The Candidate was a Resident Director at Springfield College and also a graduate student. We were not comfortable with a graduate student prosecuting undergraduate students as well as the fact that the candidate was not familiar with student issues and the judicial system at WSC. We felt that it would be possible to suggest a recommendation if the role would be administrative and not a position that would involve prosecuting students. Sue Basque has recommended that the candidate consider going to another school.

Tom Stewart - I would say Trust Fund because it would be a year round job.
 - c. *Dan Szenda* - Is there any research being done on self-supporting bookstores?
Jen Dennis - Yes.
 - d. *Dan Szenda* - How much is the Bookstore Trust Fund?
Jen Dennis - Right now we get 7 1/2 % commission from the Bookstore. Holyoke Community College runs their own Bookstore and they get 11.9%. They said that we would get more than they do because we are a larger school.
