Description:

All Council on Social Work Education programs measure and report student learning outcomes. Students are assessed on their mastery of the competencies that comprise the accreditation standards of the Council on Social Work Education. These competencies are dimensions of social work practice that all social workers are expected to master during their professional training. A measurement benchmark is set by the social work programs for each competency. An assessment score at or above that benchmark is considered by the program to represent mastery of that particular competency.

<sup>1</sup>Competencies are measure by assessing each graduate's self assessment of required practice behaviors for each competency when completing the program. Further, each student's competency on the required practice behaviors is assessed by their field practicum supervisor. The practice behaviors are assessed on a 0-6 scale where 0=unprepared, 3=appropriately prepared for entry level practice, and 6=outstanding preparation. Mastery of each competency is assessed by averaging the student and supervisor assessments across all practice behaviors for the competency and then comparing that average to the benchmark. The benchmark set by the program is at 3.0 for each competency which is appropriately prepared for entry level practice and that 90% of students will achieve a 3 or higher.
