# **Traditional Part-Time (four years) Program**

### **Course Registration:**

The program of study outlines which classes you will take each semester. The current course schedule for the fall will be available online. As a Traditional Part-Time student, <u>you will need</u> to register for the following fall classes:

#### **Field Practicum:**

As a part-time student, you will be in a field placement during your second year in the program. **To begin to learn about the field placement process, you can go to** the MSW Accepted Students webpage: <u>https://westfield.ma.edu/academics/degrees/social-work-msw/msw-accepted-students</u> and scroll down to the section: Field Orientation and Application, to familiarize yourself with the field process.

#### **Program Prerequisites:**

Some of you may need to complete either a Human Biology requirement and/or an American National Government requirement. If that is the case for you, there will be a note in this packet to that effect. The Human Biology requirement and the American Government requirement need to be completed by 9/8/23. You can complete these requirements at any college or university that offers these courses.

If you are interested, WSU also offers options to complete these requirements in house. Our noncredit, fully online Human Biology for Social Workers course is offered in the summer and meets the human biology requirement. A description of this course has been included at the end of this handbook. Please email Brandon Fredette at bfredette@westfield.ma.edu if you would like to register for this course.

We also offer a free, self-guided, open-book "exam" that will allow you to meet our American National Government requirement. You should be able to complete this exam on your own time in a matter of hours and you will have until 9/8/23 to complete it. The questions to the exam are enclosed in this handbook. Again, you are not required to complete these requirements at WSU, but you do need to complete them by the due dates. If you believe you have completed these requirements already and should not be required to complete them again, please contact the MSW Program Director, Maria del Mar Farina (mfarinadeparada@westfield.ma.edu), to discuss this.

### **Transfer Credits:**

If you have taken graduate social work courses from a CSWE accredited MSW program, you may be able to transfer up to 6 graduate credits to the WSU MSW program. To do this, we need an official transcript and a copy of the course syllabus. Once you have the syllabus, please make an appointment with Dr. Farina so we can determine whether your prior courses may be transferred for WSU MSW graduate credit.

## **Traditional Part-Time (four years) Program**

The following procedures and policies must be followed before the Program of Study is considered acceptable toward the Master's Degree. This form must be typed or printed clearly.

- 1. The Program of Study form is developed based on the program and time frame in which you were accepted. After the study plan is reviewed, it must be signed by a) the Program Director, and b) the student.
- 2. Any changes in the original program must have the approval of the advisor and the Program Director.
- 3. The Program of Study is developed in adherence to the following policies:

a. Students are expected to complete their degree requirements within six (6) years from the date of the first course credited toward their degree, including transfer credits from other regionally accredited institutions. No credit will be given for a course older than 6 years at time of graduation.

b. No more than nine semester hour credits taken at Westfield State University prior to matriculation may be applied toward the degree. Once (6) semester hours have been earned, a Pending Application Waiver must be submitted and approved prior to registering for (3) additional credits. All such credits must be appropriate to your Program of Study and must be approved by your advisor.

c. A program of study is designed in consultation with an advisor in accordance with the requirements for a degree in a specific concentration. The advisor is not responsible for his/her advisee's meeting Graduate Division regulations and deadlines. You are personally responsible for knowing and following all university rules and regulations.

4. Academic Integrity

a. Students in the graduate program are expected to have a high standard of integrity. Any graduate student who cheats or plagiarizes on examinations, papers, assignments, or within a research setting is subject to dismissal from the program. Cases involving academic integrity shall be referred to the Dean for adjudication. (See Graduate Catalog & MSW Program Manual).

### Summer 2023 Human Biology for Social Workers

Social workers, to effectively assess client systems, need to have background knowledge in sociology, psychology, political science, economics and human biology. This course will provide social work students with basic knowledge about human biology that will aid them in assessing client systems and creating intervention plans that have a greater potential to create desired outcomes. The course will explore the basics of anatomy, biological development, and heredity. Further, the course will look at issues around health, illness, disability, mental illness, the impact of substance use, sexuality, and aging. Finally, we will examine issues around Public Health.

#### Intended Audience

This course is intended for students entering an MSW program that requires all students have completed a Human Biology class before starting the graduate program. The course also is intended for BSW students who have complete their core science requirements but are still required to complete a Human Biology class as part of their Social Work Program. Since the requirements of each MSW and BSW program vary, we strongly recommend that the student check that this course will meet the requirements of their program before completing the course. A copy of the syllabus is available to document the course content to MSW and BSW programs.

#### **Credit**

This is a noncredit pass/fail course.

#### Instruction Method/Expectations

The course is offered as an on-line course that is divided into six topical modules and takes six weeks to complete. For each module students will read assigned readings, listen to assigned podcasts, complete a short written assignment, a short quiz, and/or participate in an on-line asynchronous discussion board. Students needs a computer or tablet with an internet connection. Students need a web-browser (e.g. Explorer, Safari, etc.) and a word processing program (MS Word, Apple Pages, Text Edit, etc.). Students need basic web-browser skills and word processing skills. Students will be required to listen to and possibly watch podcasts and videos. Finally students need a functional email address that is provided to the instructor.

#### This class is scheduled to start May 22, 2023 and end on June 30, 2023.

- 7. What are the Departments in the President's Cabinet?
- 8. What is the highest court in the United States?
- 9. How many justices are on the Supreme Court?
- 10. How do Supreme Court justices acquire their seat on the court?
- 11. What are two powers given to the federal government under our Constitution?
- 12. What are two powers given to the States under our Constitution?
- 13. What are two rights of everyone living in the United States?

#### Part 2: Essay Questions

(please answer each answer in your own words and in less than a page for each question)

- 1. What is the organization of the US government (including the branches of government, the roles and responsibilities of each branch, and the relationship between the branches)?
- 2. Describe the process by which a proposed legislative action becomes a law.
- 3. Describe how new laws are implemented.
- 4. Describe the process for amending the Constitution.
- 5. Describe the difference between a law and an executive order.

#### Part 3: Integrative Essay (no more than one page)

For this essay, please share your *own* thoughts about why social workers might need to be familiar with the structure and workings of the U.S. government. Then briefly discuss one example of a government law or policy that you believe is important to the well-being of social workers and/or the people we work with and explain why you think this law or policy is important.
