I hope you are all doing well and classes are going well. This is a super important dynamic. My personal goal in this role is to help open up SGA to more areas of campus, hopefully by implementing more minor ways to be more proactive and more known to the student body. Here are a few updates that have been here since last year. The Banner name change application, which is a way for students to able to change their names, needs to be on all

Westfield software is still being worked on. I know the deadline of June was given to SGA last year, but there are still some things that are keeping that process held up. I am going to try and see if we can get an email sent to the student body with an update because I know students who are returners are looking for some type of update. I want this to happen in the next few days, and I will be working with the committee chair to get an email out to students to update them on the process, making sure we prioritize transparency in the process. I also will work with the committee chair to ensure they educate students so they can be more aware of updating their names when the system is up and running.

 - A. Vice President of Enrollment Management & Student Affairs: Dr. Kevin Hearn

I was told that you have to clap. I told someone to come here, so I wanted to hurry from the other side the room. Good afternoon, everyone. Thanks for having me. I'm brand new to Westfield State. I'm in the process of moving here from New York, from a city. I don't want to speak up because we gave away a football game last night. Yeah. But I'm very excited to be a part of Westfield. I was on campus many, many times before you were all ever born in the 90s when I worked out in Eastern Mass and had the opportunity to live in or stay in the residence halls of our residence hall association meetings, New England group might not still exist. Yeah, so, So the opportunity to come back to Westfield is sort of coming home for me. So I'm very excited about the work ahead. I am responsible for two of the critical areas on campus, student Very much looking forward to working with all students, current perspective and alumna to improve the student experience in a very comprehensive way. And I explained this to faculty to trustees as follows. From the point of the hand that gets raised in your sophomore year of high school to when you get a job as an alum. That all falls within my areas of interest and everything that comes to the student

experience. So while I don't have authority for everything, I'm generally interested in your feedback on how we can make improvements to experience. You're having students of all types on campus, traditional students, commuter students, international students, non-traditional students, day students, night students. All sorts of student and I an very much interested in learning from you about what drew you to Westfield State and how I can, in my work with the Cabinet, make the necessary improvements to continue to evolve the Western State experience. So I can go on and on about that, but you're not particularly interested. So let me is it prudent, Mr. President, to open this up to questions if there are any.

- i. Daniel Currier: Hi Dr. Hearn. So I know at the beginning of your tenure we were projecting 100 less students for first years than we were anticipating so how have things turned out for the fall and what were some areas that we did really well and some that we fell flat on?
- ii. VP Hearn: Well, about 89 students short of where we have to be. Now, I'm not terribly concerned about that because our targeting for that number, which was roughly about 775 students, wasn't as precise as I feel like it needed to be. One of the things we need to think about is the demographics and 17 or 18year-olds and your particular areas of interest, the scope of our programs that we have and so on and so forth. But to be very specific. Um, Where we didn't do as well may surprise you. It's within the state, what I would call our backyard. So one of my particular areas of focus is really working with the marketing team to build a brand, build back a brand for Westfield State. I'm sure you would all like to see your logo and your institution lifted up the lawn in front of the rest of the Commonwealth and it's very much in our interest to do just that. So we are positioning a proposal in front of the Board of Trustees for them to make a significant investment in a full branding study for the university, which is different. Any marketing majors here? Different from a marketing strategy, but we expected. Be very loud, very proud in our approach to lifting up and showcasing Westfield State for prospective students going forward. We are changing the open house strategy. We are changing our visit strategy. I I think I can announce that we are moving all campus tours out of Forest Man and into the new parental building. So for those of you that toured and started all the way over there and walked through the snow or the sleet or the rain or whatever it might have been. We're going to bring all of our new visitors right to campus and focus on what's what's most important to them. So we're excited. We believe that will have a significant impact going forward as well. Absolutely. There's a great opportunity for us to coordinate our efforts more deliberately and intentionally with academic affairs and working with faculty. If you think about your own experience, I think there's a sense of belonging that comes to a visitor to campus, and that's critically important that you make your decision. But as important generally later in your decision making process is meeting and hearing more about the actual academic program that you're coming to study at. So there's One of the reasons why I chose to apply for the job in the first place. Disappointing where we stand, but tremendous opportunity going forward.
- iii. Nick Smith: Hello, thank you for coming down. We really appreciate it and it is nice to have you here as our first speaker back on campus. My question is, I know that the student experience is super important to you. Could you share a little bit about what you've done so far and what you plan to do to shape the student experience.
- iv. VP Hearn: I can't use the word shape just yet. It's only about a few days, right? But one of the things I've done is and will

continue to do is I'm going to be on campus around the corner here near Dunkin' Donuts. Keep that door open so I can listen. Quite a bit to what's happening for students. I've been surprised to hear all of what I've been able to hear. The students are waiting in line for your Dunkin you're buying. But I also need to get out there. You know, I need to get to club meetings. I need to get better comments that you can get the theater productions, that need to get in the residence halls and you can come back here and just sit in the back room and listen to what your particular issues are. It's not my job to shape. It's my job to organize your resources so you can all shape it. So my hope is that we'll continue to dialogue as an organization, as the vice president, that being the students and t So we can know in a moment 's notice what we can do. We're talking about the infrastructure literally how many times a week does this elongate mode, we're talking about dining hall, we're talking about activities on campus. We're talking about the activities budget. I challenged Matt with some big thinking around what he might do if we were to get crazy with the resourcing of some additional activities on campus. Integration with athletics needs to be I think something that we look at but. Every time I say something that it sounds like judgment, as if something's broken. I've only been here for two weeks that the students have been here. So, in terms of the experience, I'm all ears at this point. So whether you're formally scheduling a meeting with me or you're just popping in, please don't be shy. I'm running shared office hours with Jack over there. They start on Thursday, right? Yeah, we'll get word out so folks can know they can just pop in. We are also going to publicize some shared office hours with Doctor Thompson. We'll be over here with me. So we can again be very student centered by being in the center where students are and hearing about your experience, because I know very well with my experience was 30 many years ago. But I'm very interested in understanding what your experience is, because I would believe it's vastly different from one student to the next, from the alumni story to the prospective student story. Right. So maybe I'll maybe I'll leave it at that. I'll just say please don't be shy. I have a lot to learn as the new Vice President, I'm supported by Barry Talent. It's that I think you as an organization, I've been impressed by this organization to this point. I thought Nick's words in particular at the convocation. We're right on point. Um, he did better than anybody else. Sorry, Maggie. He did better than everybody else on the stage. And I think that speaks volumes to all of our perspectives about what the student government expects of them. So, don't be shy. Please continue to communicate with me and let's work together to do some really outlandish things this year.

- v. Sarah Harington: As you know we have a new interim provost. I just wanted to know if you have met with him yet and whether you are working to have amore cohesive relationship between student affairs and academic affairs because I know that can be a problem.
- Vi. VP Hearn: It should never be a problem, but it can be a problem at times. I'm very excited to be working with Doctor David Caruso. Dr. Caruso and I meet twice a week. We have lunch in the dining hall every week. We're talking about very strategic initiatives that start with much more collaboration between his area and, frankly, all areas of the universe. You know, we are at our core and Academy of learning and we need to recognize the importance of that experience, but in no way engage the critical nature of the learning environment outside the classroom. I think Doctor Caruso shares that perspective with me. I think we're very excited to be on campus seeing and working, seeing, working

together. I've been in rooms where he's lifted up the efforts of enrollment management and student affairs, and that's great for me to hear him do that and he should fully expect it. I'm going to lift up over the accomplishments of faculty, but I hope his students, you will see a very seamless partnership between academic affairs. With the current temporary Provost, which is exact title Temporary Provost, the search in the new permanent Provost, that is very much one of the primary drivers for me going forward.

IV. BOARD OF TRUSTEES' REPORT: Daniel Currier Good evening, and welcome to SGA!

My name is Daniel Currier, also known as Mr. Westfield. I am an accounting and finance double major with double minors in English and economics. I am also a member of the Honors Program. I am from Attleboro, MA, and in my free time (if I somehow have any), I enjoy hiking, going to the gym, and watching documentaries.

Most of you knew me from last year talking about fringe benefit rates and budget line-item allocations in my role as the SGA Vice President for Finance. This year, I have the honor of serving as your Student Trustee. In this position, I serve as the Student Representative on the Westfield State University Board of Trustees - the governing body for our institution. The decisions this body makes include the passage of the University's budget, the setting of student fee rates, non-academic policy revisions, and more. I serve alongside ten distinguished community members ranging from the Mayor of West Springfield to the Chief Financial Officer of Big Y Foods. They bring valuable political, business, legal, and higher education experience to the table. As a trustee, I have a duty of loyalty and care and a fiduciary responsibility to this institution. My positions on issues affecting our campus will be based on these responsibilities while recognizing the needs and desires of the student body that I serve. I look forward to working with the Board over the next year.

My term officially began on July 1st, and we have already been hitting the ground running. Since my appointment, there have been four meetings of the Board of Trustees and we have done the following:

 \cdot On July 21st, the Board of Trustees voted to create a new Advancement, Marketing & External Relations Committee in recognition of the important need

for the institution to expand and improve upon its marketing and fundraising efforts. We also voted to authorize the transfer of

\$25,000,000 in reserves from Westfield Bank to a higher interestbearing account with Federated Hermes / Massachusetts Municipal Depository Trust in order to take advantage of current interest rates.

- \cdot On July 27th, the Board of Trustees met in executive session pursuant to an exception to the Massachusetts Open Meeting Law allowing the Board to discuss litigation strategy, as public proceedings would impact our litigating position. Given the confidential nature of this meeting, I am not able to disclose any information at this time.
- \cdot On July 28th, the Investment Subcommittee met and approved an updated charter and further discussed the current investment climate.
- · Finally, on September 8th, the Board of Trustees met for two key purposes: to approve the President's evaluation and to discuss the possibility of migrants being housed in Lammers Hall. Regarding the President's evaluation, I am pleased to report that her evaluation was exceptional, and that the Board recommended that the Commissioner of Higher Education grant President Thompson the highest possible compensation increase allowable. I invite you to read the President's evaluation by the Board on the Board of Trustees webpage under the agenda for the September 8th meeting. Regarding the migrant housing situation, the Board was universal in its opposition to the proposal by the Healey Administration to house migrants in Lammers Hall. My concern as Student Trustee is the impact this decision will have on our enrollment and financial health. Other concerns expressed by trustees and President Thompson include the layout of Lammers Hall, impacts on mental health counseling, the lack of accessible urgent care services, the likelihood that the state would not reimburse the University for services rendered, and the timeframe, which would be indefinite. The Board has not yet taken an official position, but the meeting demonstrates that we all have serious concerns about this proposal.

As the Student Trustee, my top priorities this year are to stabilize and increase our institutional enrollment, to lead the University to financial success, to improve the student experience (including student employment and form digitization), and to move the University forward as it seeks to fulfill its IDEAS framework.

I am currently working on meeting with various offices on a proposal to centralize student employment postings and information. This would be for both work-study and non-work-study positions on-campus. I will keep you updated as I have further meetings.

Finally, I want to let you know that - in an SGA first - I will be missing the SGA meeting next Tuesday, as I will be at a Board retreat from 8:00am-6:00pm. This Board retreat, which will be held at Great Horse Country Club in Hampden, MA, will give members the opportunity to engage in a governance workshop and a strategic visioning session. Should I have anything to report that evening, another Exec member will present.
