<u>Board Annual Assessment</u>. The Board would like to hold small focus groups with constituencies that interact with them enough to provide valuable feedback on Board operations, institutional performance, community relations, and policies. Questions could be provided to the groups prior to the meeting so they would know what the Board hopes to learn from these sessions. Dialogue with the focus groups could be formative in learning what can be done better and contribute to increased transparency and shared

governance. Logistics will be developed over the summer and the focus groups scheduled for the fall using the same topics as the Board self-assessment in June 2021.

<u>Officers of the Board and Annual Committee Assignments</u>. In preparation for the June meeting, if Trustees have an interest in serving as a Board officer, let Trustee Alvarado know. Trustee committee preferences will be requested within the next few weeks.

<u>Board of Trustees Bylaw Draft Review</u>. The bylaws were compared to those of sister institutions and suggested revisions and questions were presented for review. Trustees were requested to take time to review the draft based on how it lines up with NECHE standards and to think through the questions, which will be discussed at a future meeting.
