III. PRESIDENT'S REPORT: Aaron Lessing

Hello everyone, I first want to welcome everyone that is new and congratulations on your new position. My name is Aaron, and I am the President for the 2022-2023 academic year. For those of you that are new, please bear with me during this meeting, Robert's Rules of Order can seem intimidating but do not worry we will have a quick training later in the meeting. If you do have any questions for anyone throughout the meeting please wait until we ask if there are any questions then raise your hand, we keep a list of people that want to speak. We do have some guest speakers today, first we have the Dean of Students Maggie Balch, Associate Dean of Students Shannon Green, and the Director of SAIL Matt Dellea.

- A. Dean of Students: Maggie Balch, Associate Dean: Shannon Green, Director of SAIL: Matt Dellea
 - 1. Maggie Balch: I'm conflicted because I'm used to all of you looking straight at me and not all around. But, I do like the all around because I think that it's more community focused. Hello, and welcome everyone. My name is Maggie, I'm the Dean of Students, my office is upstairs in Ely 209. The Dean of Students is the one who sits in the room and if there aren't any students there, I need to think like a student. I need to think about what your experience is like on campus and I need to advocate for the things that you want that are appropriate and I need to make sure that your voice is heard throughout campus. So this venue is super duper important to me because I learn a lot about your experience, about what you are looking for, about what's working on campus and about what's not working on campus. I learn what you're curious about, if you need more internship opportunities, and I learn an awful lot about dining services. I learn a lot about how you are experiencing your academics so I can go and champion some of your problems. So if as you are thinking about things and moving about your day and you are moving about the campus green, and you think this would be a really great thing for Maggie to think about, please come and find me, I'm here almost every Tuesday and my office is upstairs where I do have office hours. I will ask that if I send an email, that you see a big long email, there's probably something important in there so please read it. In the past three years, I was the Covid updater but I am not anymore. And I'm really glad about that. Covid is still a thing but at this point most everyone is past since they are vaccinated and have kind of transitioned from the pandemic to the endemic phase of things. But if you have Covid questions, I can probably answer them. The departments that I oversee are residential life, health services, the counselling center, S.A.I.L.
- 2. Shannon Green: Matt and I are apparently referred to as Mr. And Mrs. Westfield. So if you see one of us then you'll probably see the other in a variety of different capacities. support on student activities, student government, new student orientation, and the parent and champion programs. So I do get some fun in my job along with the heavy. 3. Matt Dellea: Hi I'm Mr. Westfield, otherwise known as Matt Dellea. As mentioned before, I'm the Director of student activities involvement in leadership or SAIL. I'm new to the position this year as SAIL has gone through some changes which some of you may or may not be aware of. So I'll talk about those as Student Government Association in the past you have kind of been your own entity of reporting up to our Dean of students office. Moving forward, the office of student activities and student government have come together to form one department where I'll oversee the activity component that's going on. Then underneath that we have Laura who works in our office and is over here working with you all and student government. Then down the hallway we have our campus activities board, student leadership, new student orientation and then behind you in this small office here we also have commuter life with Mia who is in the process of being hired. She's going to be with us a few hours as a graduate student to focus on our commuter student programming. In my role it's really a lot of fun. I'm the one that brings all of those comedians and hypnotists and paint nights and all that fun stuff to campus. So if you were to test positive and somebody were to say call health services. You would be directed to Tiffany, and Tiffany would walk you through the next steps. If you test positive, you need to isolate for five off campus and if your symptoms have diminished after five days, you are welcomed back on campus with mask to go about your day.
- iii. Rodney Duteau: This is going back with quarantining, for students who are going through housing insecurities where Westfield is the only place they can stay. How does that apply to them?
- iv. Maggie Balch: Thank you for that. If you do not have a place to isolate off campus, we have one available apartment on campus which we are sharing with admissions because it's the admissions showroom. It is the gift that keeps on giving and so if you do not have a place to go, we will not kick you out onto the street. We will stick you in apartment, most likely with other people that have tested positive.

B. SGA Advisors: Ryan Meersman & Laura Cafaro

Aaron Lessing: Our next guest speakers are our SGA advisors, Director of Alumni Relations Ryan Meersman, and our Coordinator of Student Involvement Laura Cafaro.

1. Laura Cafaro: Hi everyone! My name is Laura Cafaro, and I'm the coordinator for student involvement here at Westfield. Mainly with in that position, I advised our wonderful SGA. So it's very fun and exciting to see some new and familiar faces here. So welcome everyone and all of our new students who are joining us today, after our elections went through. We are very happy to have you all here and also see first year students so excited and ready to get engaged and involved on campus. So it's really fun for me to see. A little bit about my position on campus. I mainly advise our SGA, so my office is right to the corner when you walk into our space, I'm on the left. I like to share that if the palm tree is on, that means that I'm also here and happy to help you with anything. I also assist with orientation mainly with our champions network so all of our families, guardians, and any support units that students have as they join us our campus. I help interact with them and help them also acclimate to our campus 'cause they also joined our family when their student joins us. I also help our clubs and organizations on board and help them with any fund-raising process. I've been getting a lot of emails lately about what their club budgets look like so that's fun, It's either an excited voice in response when I share their name or a little bit of an oh no. - 2. Ryan Meersman: My name is Ryan Meersman, I'm the associate director of alumni relations here at Westfield state. I'm also a double alumnus. - ii. Ryan Meersman: So I will I'm going to answer it this way and I'll let Matt answer differently. This year is the first time in recollection of anybody, since I've been part of this university that we really are trying to get students to be involved and so that kind of got a bit of a late start this year as we rolled out this new plan for homecoming that there would be a lot of student involvement. Our hope in the future is that we have a student committee that would really work on events like that for you guys so I don't know what the status of a lot of like student programming is for that like Friday, Saturday but Matt do you have anything add.
- iii. Matt Dellea: Come to CAB tomorrow at 5PM where we are on Student Programming for homecoming, and we would love to have your feedback on the dance and see if we can make something happen.
- iv. Chloë Sanfaçon: Can you describe what homecoming usually is since you said that it is changing.
- v. Ryan Meersman: Yeah, so in the past homecoming has taken on a couple of different shapes. We try to attract alums back to campus to see what's happening and to reconnect with each other and reconnect with their academic departments if they have the opportunity to and we also give out some awards to alums. Last year for instance was mainly focused on that Saturday of the weekend, where we did distinguished alumnus award down here in SGA for Representative Bud Williams, so we had a nice sort of breakfast reception for him and an award ceremony and then we were down at game side at alumni field for soccer and football and then in the evening there was an event in Scanlon that alums and 21 plus students were able to attend. This year a lot is different. It starts on Thursday. Then, 21 plus students and alums are all invited to an event at great awakening brewery that night and then a jazz brunch on Sunday.

Hello! Food Services meets tomorrow 10am in the DC. I brought up everyone's concerns and notes from the last SGA Meeting. So before getting to a lot of the new stuff, let me run through last week's issues.

1. DC Closed an hour earlier than it should've or ran out of food an hour earlier. I mentioned this to them, and I tried to explain as best as I could but everyone in the meeting had no idea what I

was talking about and said in either scenario they would've know because that is their lunch break time.

- 2. They are going to get their signs back for when they have menu transition periods, they DC never "closes" during operation hours which are 7am 8pm, Late Night Bistro is 8pm 11pm. But they do transition menus for breakfast, lunch, and dinner. Typically, Pizza, Salad, and Burgers are a constant option during these periods. They are doing their best to keep up.
- 3. The certain cashier(s) who have been turning people away during transition or saying there is no food so they can't swipe was told the correct information now and there should be no more problems. There was miscommunication, so if you are going in for a coffee or cereal or a fruit bowl you can even if there is no main foods readily available and not get turned away.
- 4. If you would like a breakfast sausage egg sandwich with no cheese, all you need to do is ask the lady at the grill and she will make you one.
- 5. I mentioned how well received the slushies were in market and there was a mention of expanding flavors, such as Apple Cider flavor.
- 6. Bill's recommendation for student athletes where they are getting held up at practice and unable to get food. Which is to get the to-go boxes and then get their dinner or food and then keep it in their fridge for after practice. They are talking to athletics about this they said.
- 7. Late night bistro meal swipes were temporary for when bistro options were moved into the DC last year. But now that late night is back in place it went back to how it normally goes.
- 8. Make your own for paninis and smoothies will return to the Bistro as soon as they get more people manning the stations, currently one person per station.

- 1. The food winner of the 20-vendor lunch last week was the middle table with the Asian cuisine, which were three different dumplings and fried rice. Dinning will be incorporating them into menus and in a rotating bowl in bistro.
- 2. Bistro will be incorporating a rotating 7 option menu such as Asian bowls, uncrusted pizza, the current burrito bowls, ect.
- 3. There will be weekly new food testing at the center table in the DC, last week they did a different type of salad. So go test those out.
- 4. Latinx Week will be next week at the international station.
- 5. Pepsi Gatorade Sampling, as well as new Starbucks seasonal bottle frappe option sampling in the DC coming in the next month or so. Part of the Wilson Café changing up to seasonal menu items.
- 6. Marketplace is looking into getting pizza and grill options.
- 7. October the DC is making the switch to serving Hot and Cold Apple Cider. In November and December, they will be serving Hot Chocolate.
- 8. Stir-fry will be back around the 1st week of October.
- 9. DC looking into local partnerships with local farms for fresh produce.
- 10. The DC needs students to work, they will hire even if it is one day a week.
- 11. Philly Cheese Steak premade melt will be available within the next week in Bistro.
 - i. Aaron Lessing: I'm not mad that the dumplings won, but can you have them consider bringing the smoothies that were there. Because the smoothies were amazing as well and they would be much better than the smoothies in Bistro.
 - ii. Logan Terenzi: I will ask that. I really liked the smoothies too.
 - iii. Dan Currier: Do you have any updates on dining dollars conversation for bistro late night. iv. Logan Terenzi: Yes, I somehow skipped over that. That last semester last year when late
 - night was moved into the DC. Just for ease of access to late night in the DC, they did a temporary switch to using meal swipes at late night. That is not how it usually works and actually has never been the case in the past and it was just because Bistro was shut down. Bistro is now open and fully functioning so it's back to how it usually is where you must have dining dollars for late night. It's always been like that since I got here and that's just how it works.
 - v. Chris Lannan: One of the things that the whole freshman class is asking for is energy drinks in the DC. Is there any option where we can get them?
 - vi. Logan Terenzi: I will bring it up with Bill tomorrow.
 - vii. Guest question: I know that a lot of students has also been asking for cheese stuffed pretzels to be served more often.

 - x. Logan Terenzi: When you walk into Bistro, you want to go to the left where the drinks are and usually there's the grill and pickup options. Right where that little window is where you

can see the lady grilling, you want to flag her down and say I want an egg sandwich with no cheese and she'll make it for you and hand it to you. Last semester, they used to make chicken sandwiches to order and it's basically the same thing with this.

- **C.** Special Committee on Reforming General Education (SCORE):**Emily Fluet** So, first for anyone here who doesn't know, I just want to explain what SCORE is. VII. VICE PRESIDENT'S REPORT-FINANCE: Daniel Currier

Good evening everyone, and congratulations to our new members!

My name is Daniel Currier and it is my honor to serve the student body in the capacity of Student Government Association Vice President for Finance. For those new to SGA, the Vice President for Finance is responsible for overseeing the distribution of funds from the SGA Trust Fund and working with clubs on financial matters, including fundraisers and finance proposals for additional funds. The Vice President for Finance is also charged under Article IV of the *Student Government Association Bylaws* to uphold the our finance rules and regulations. The Vice President for Finance serves as chair of the Finance Committee, Student Organization Council, and the SGA Club Representative Committee, and serves as the Student Director on the Westfield State Foundation Board of Directors. I am also serving on the Interfaith Advisory Council, New England Commission of Higher Education (NECHE) 2023 Self-Study Committee, Information Technology Strategic Advisory Commission (ITSAC), and the Academic Policy Committee (APC).

In line with my responsibilities, I have a motion tonight concerning finance proposals. At this time, Finance Committee (which I will explain during new business) has not been filled for the 2022-2023 academic year. Although the Executive Council is able to approve club constitutions when the Rules & Regulations Committee is not in session under Article IX, Section 3, Subsection J of the *Student Government Association Constitution*, the approval of finance proposals is left ambiguous. A club has emailed me expressing interest in submitting a finance proposal. I hope to have this heard by the Executive Council on Monday and approved by the Student Government Association on Tuesday in accordance with Article IV, Section 5 of the *Student Government Association Bylaws*. Although I will be looking to change the Finance Bylaws this semester to allow the Executive Council to fill in for the Finance Committee when they are not in session, I want to ensure that any discussion we have prior to the passage of amendments is in line with statute. Therefore, I will be making the following motion:

I move to grant the Executive Council the authority to review finance proposals submitted by SGA-recognized clubs and organizations under Article IV, Section 5 of the Student Government

<u>Association Bylaws</u> and submit an opinion to the Legislature for final approval. The terms of this motion shall expire upon the first meeting of the Finance Committee for the 2022-2023 academic year. *Motion carries*

A. Finance Committee: No ReportB. Foundation Report: Dan Currier

Hello again! The Westfield State Foundation Board of Directors held its regular meeting on Thursday, September 21, 2022 in the University Hall Meeting Room at 4:30pm. The meeting was attended by members of the Westfield State Foundation Board of Directors, Vice President for Institutional Advancement Lisa McMahon and members of the Institutional Advancement Team, and President Linda Thompson.

The highlights of the meeting include the approval of an unmodified (or good) opinion of the Foundation's financial statements for FY22; a presentation on the Foundation's investment portfolio, which is down by nearly \$2.5 million due to the ongoing Wall Street selloff; the approval of the Interfaith Center budget; and a report by Vice President for Institutional Advancement Lisa McMahon and her staff on the upcoming scholarship fundraiser, Homecoming Weekend, the Fall Appeal, and the recently-held Golf Tournament. President Thompson also gave a report on what she has been doing to advance the mission of our University.

A dashboard was also provided which I have printed for all of you so you can understand the impact that the Westfield State Foundation and the contributions of nearly 1,500 donors have on our campus as of the conclusion of the 4th Quarter of FY22. The number of donors has increased to the highest level since before the COVID-19 pandemicfor FY22. Most of our donors graduated from Westfield State University (then known as Westfield State College) in the 1970s and 1980s. The Institutional Advancement Team has worked to integrate payment through Venmo, Paypal, and Apple Pay as a means of acquiring greater fundraising dollars from our younger alumni.

The Foundation spent over \$600,000 on scholarships for our students last year and looks forward to continuing to support students when scholarship applications open next spring. Pursuant to the *Memorandum of Agreement* between the Westfield State Foundation and Westfield State University, the Foundation will also be providing \$350,000 in recruitment and retention support, \$100,000 in a final payment for Dever Stage seats, \$125,000 for internship support, \$30,000 for student emergency support, and much more!

I gave a report to the Board of Directors at the conclusion of the meeting that spoke to SGA's theme of "Building the Nest," but in the context of the Foundation and the University in general, "Rebuilding the Nest." I spoke about the proposed Expedition Owl Program whereby

students could act as ambassadors for Westfield State University at their high school and beyond, which was met with enthusiasm. I also discussed the relaunch of the Nestwork and the several opportunities we have working with the Office of Student Activities, Involvement, and Leadership.

Following our regular meeting, we held the Annual Meeting of the Corporation in the University Hall Multi-Purpose Room, which was complete with a buffet dinner and alcoholic beverages, so it was odd being the only director under the age of 21. The Annual Meeting of the Corporation saw an address by President Thompson focusing on the need for philanthropy to cover our outstanding needs here on-campus, an overview of Interfaith Center operations by Father Savage, a speech by our own Vice President for Academic Life Emily Fluet on student scholarships, and a heart-wrenching ceremony where the Foundation presented a local company and their employees an award for going above and beyond in offering support to the Common Goods Food Pantry and our students who are in foster care and/or are housing insecure. Fifty first-year and transfer students fall into this category this year, so it is important that all members of our community assist those who need our support.

I will keep you all posted on fall philanthropy efforts, including the Fall Appeal, as they approach. The next meeting of the Foundation will be held on Wednesday, November 16, 2022. Should you have any questions, please let me know.
