Course Description:

This course is for graduate students working towards board certification in Applied Behavior Analysis. Students will be introduced to ethical topics in ABA and complete in depth study of the Behavior Analyst Certification Boards' Professional and Ethical Compliance Code for Behavior Analysts. Readings will highlight important perspectives on the ongoing evolution of ethics and social validity in the field. Students will be challenged to consider appropriate decision making in case study scenarios, reflecting on their own personal views of what is good and ethical, the radical behaviorist approach to "good" and ethical behavior, and the BACB Compliance Code.

Scheduling and Deadlines:

Each Tuesday, a week's assignments will be available for completion. All assignments must be completed by the following Monday at midnight. Course Objectives

Throughout this class we will discuss many topics within the field of ethical responsibilities in Applied Behavior Analysis such as

- Compliance code, laws and regulations pertinent to professional activities in Applied Behavior Analysis including special populations such as children and individuals with developmental disabilities.
- Core ethics of science and ABA
- How to systematically carry-out an ethics decision making process in professional ABA case studies.
- How to recognize and avoid professional conflicts of interest.
- How to ethically respond to suspected conduct violations.
- How to ethically obtain informed consent, including with vulnerable populations.
- How to ethically approach the protection of confidential information.
- How to ethically approach behavioral assessment and functional analysis.
- How to ethically select target behaviors for change and intervention goals.
- How to ethically select, implement, monitor and evaluate behavior change procedures.
- How to ethically approach supervision and teaching responsibilities.
- How to fulfill ethical responsibilities to staff, students, colleagues and the field of ABA.
- How to fulfill ethical responsibilities to society.
- How to ethically conduct applied behavior analytic research.

- Quizzes will be posted each week and must be completed by midnight on the due date.
- Format will be multiple choice, true/false, short answer
- Content will be based on Bailey and Burch chapters, BACB Compliance Code, posted lecture/presentation materials, and other supplemental materials as announced.

25% Reading reactions

- Each week, you will write and post a 2 page summary and reaction to the assigned articles. 1 page of the paper should be a CONCISE summary, while page 2 should be a reaction to the reading. Papers which are substantially below or above the limits listed here will be penalized.
- In addition, you will review one other student's reading reaction and post 1 to 2 meaningful comments about their paper.
- Detailed assignment instructions will be distributed.

25% Case study decision and defense papers and/or other activities

- Case study scenarios and or activities related to ethical concerns will be posted.
- For case studies, you will choose one case to review, determine an appropriate ethical solution, and write a 1-2 page defense of this decision, and/or create a podcast (as determined by weekly assignment), citing appropriate BACB codes and other sources as needed.
- For case studies, you will also select another student's posted defense and write a 1page argument, and/or create a podcast (as determine by weekly assignment), for an alternative solution.
- Detailed assignment instructions will be distributed for other activities such as consent form creation and/or interviews

25% Cumulative final exam

- Short answer and long essay format covering all course material
